

Including Manchester City Galleries in your Will

Manchester City Galleries is a department of Manchester City Council and has two flagship venues, Manchester Art Gallery and the Gallery of Costume at Platt Hall. Every year the Galleries raise funds to: deliver capital projects; mount exhibitions and displays; conserve works from the collections; acquire new items for the collections; and deliver an education, outreach and public programme of events.

The most tax effective way to leave a gift in your Will for the benefit of Manchester City Galleries is to leave it to Manchester Art Gallery Trust*, the independent charity that raises vital funds to support the activities of Manchester City Galleries.

There are two main types of money legacies, residuary and pecuniary.

RESIDUARY GIFT

This is all or a proportion of your estate after taxes, debts and expenses have been paid. The residue can be shared amongst family, friends and charities in whatever portion you decide. With residual gifts, the value of your gift will not be reduced by inflation over time so it is particularly helpful.

The suggested wording for a residual gift is:

'I give all the residue (or x %) of my estate to Manchester Art Gallery Trust, Manchester Art Gallery, Mosley Street, Manchester, M2 3JL, registered charity number 1048581, for its general charitable purposes. I further direct that the receipt of the Director of Manchester City Galleries or duly authorised officer of Manchester Art Gallery Trust shall be a full and sufficient discharge for the legacy.'

PECUNIARY GIFT

This is an exact sum stated in your Will. As its value will decrease over time due to inflation it is wise to ask your solicitor to help you review the gift.

The suggested wording for a pecuniary gift is:

'I give the sum of £x to Manchester Art Gallery Trust, Manchester Art Gallery, Mosley Street, Manchester, M2 3JL, registered charity number 1048581, for its general charitable purposes. I further direct the receipt of the Director of Manchester City Galleries or duly authorised officer of Manchester Art Gallery Trust shall be a full and sufficient discharge for the legacy.'
